

## General Training – Supplemental Labor

The following courses are Institutional Training Requirements that are required for Supplemental Labor Contract employees who are expected to perform work for LLNS more than 14 days in a year. These courses are not specifically associated with the employee's work assignment and should be charged to project/task 40415/INST\_TRAIN. The top section shows courses that are required when the person initially works for LLNS and the bottom section shows courses that have annual or biennial repeats.
